

RESOLUTION NO. 29 - 2015

A RESOLUTION ESTABLISHING THE "2904 SCHOOL RESOURCE OFFICER (SRO) FUND" OF PERRY VILLAGE, OHIO, AND DECLARING AN EMERGENCY

WHEREAS, Council has been advised by the Auditor of the State of Ohio that, in accordance with the provisions of Section 5705.12 of the Ohio Revised Code, there is an immediate needs provide for the creation of the "Village of Perry 2904 School Resource Officer (SRO) Fund;" and

WHEREAS, the Ohio Revised Code further provides that said Fund shall established to provide for the proper and prudent investment, direction, management and control of money derived from specific sources other than general property tax; and

WHEREAS, Council finds it to be in the best interests of the Village that such Fund be established and approved.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PERRY, COUNTY OF LAKE AND STATE OF OHIO, AS FOLLOWS:

Section 1. That, pursuant to and in accordance with the provisions of Section 5705.12 of the Ohio Revised Code, there is hereby authorized and established "The Village of Perry 2904 School Resource Officer (SRO) Fund" that shall provide additional means for the fair and proper investment, direction, management and control of Village revenue and funds.

Section 2. All formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.



Said Resolution is necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Perry.
