

RESOLUTION NO. 55-2015

**A RESOLUTION APPROVING AND
ADOPTING THE PERRY VILLAGE MAYOR'S COURT
SESSION DATES AND WAIVER SCHEDULE
AND DECLARING AN EMERGENCY**

WHEREAS, Council has been advised that it is necessary to revise and establish a new and "up-dated" schedule of Mayor's Court sessions and waiver schedule applicable to those various those charges brought in the Village's Mayor's Court; and

WHEREAS, Council finds it to be in the best interest of the residents of the Village to provide for same.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF PERRY, LAKE COUNTY, STATE OF OHIO:

Section 1. That, effective the 1st day of January, 2016, "The Perry Village Mayor's Court Session dates and Waiver Schedule" (that is attached hereto as Exhibit A and made a part hereof) is approved, authorized and adopted in its entirety.

Section 2. That all formal actions of this Council concerning the passage of this Resolution were adopted in an open meeting, and all deliberations of this Council, or any of its Committees, which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


